1	Department of Central Excise and Service tax	24-09-2018	The Excise Department had issued an order directing the inclusion of software value in hardware for the purpose of calculating excise duty, resulting in a demand of Rs. 42.93 crores. Tejas Networks had challenged this order by filing an appeal before the Honorable CESTAT, Chennai. Subsequently, Civil Appeal No. 011078 was filed before the Honorable Supreme Court (SC) during September 2018, and the same is currently pending. The case has been listed for hearing via video conferencing. The Advocate-on-Record has been informed to request a physical hearing. No further updates have been received from the Supreme Court at this time. Separately, the Department had filed an application for early hearing before the CESTAT, which was disallowed on 22nd October 2021.	There has been no further development in the matter during the quarter April - June 2026. However, the matter was listed in Supreme Court on 8.07.2026 but not heard and adjourned.
2	Principal Commissioner of Customs , ACC, Bangalore	15-04-2025	A writ petition No.11707/2025 was filed by the Company on 15th April 2025 before the Honorable High Court of Karnataka, challenging the Order-in-Original No. 582/2024-25 AP and ACC dated 13.01.2025. The Honorable High Court has on 21st April 2025, granted an interim stay against the the order of Commissioner of Customs.
